

Requirements for Registration of Organic and in Conversion Plant Reproductive Material in the Swedish Database

To meet the requirement that the plant reproductive material must be available on the territory of Sweden (according to Article 26.1 and 2a in (EU) 2018/848) we have the following requirements¹.

Last Date for Registration

The suppliers must register plant reproductive material (PRM) no later than:

1. 20th of October in the year preceding the spring season for species intended for sowing and planting in the spring, and
2. 1st of June for agricultural species intended for sowing in the autumn, and agricultural and vegetable species intended for planting in the autumn.

Available PRM

Registered material shall be available for order no later than:

1. 1st of December for species intended for sowing and planting in the spring, and
2. 10th of June for agricultural species intended for sowing in the autumn, and agricultural and vegetable species intended for planting in the autumn.

Quantity in Weight of the Seed

To register plant reproductive material, the quantity in weight of the seed of the following crops also has to be at least:

1. 500 kg for Winter Oil Seed,
2. 3 tonnes for Potatoes,
3. 5 tonnes for Blue Lupin -*Lupinus angustifolius*,

4. 25 tonnes for Cereals and Pulses,
5. 3 tonnes for Fodder Maize,
6. 1 ton of Grass Seed for Fodder purposes of
 - a) English ryegrass - *Lolium perenne*,
 - b) Cocksfoot, Orchardgrass - *Dactylis glomerata*,
 - c) Italian ryegrass - *Lolium multiflorum*,
 - d) Alfalfa - *Medicago sativa* L,
 - e) Festulolium - *Festulolium* (*Festuca* ssp. x *Lolium* ssp.),
 - f) Red Clover - *Trifolium pratense*,
 - g) Red Fescue - *Festuca rubra*,
 - h) Tall Fescue - *Festuca arundinacea*,
 - i) Timothy - *Phleum pratense*,
 - j) White Clover - *Trifolium repens*,
 - k) Westerwolds Ryegrass - *Lolium multiflorum* var. *westerwoldicum*,
 - l) Kentucky Bluegrass, Smooth Meadowgrass, June Grass, Spear Grass - *Poa pratensis*,
 - m) Meadow Fescue - *Festuca pratensis*, and
7. 200 kilos of other species of grass seed intended for fodder purposes.

Deregistration

The suppliers must deregister the plant propagation material when the quantity is less than the quantities specified above. Registered plant propagating material of cereals and pulses must, however, only be deregistered when the quantity is less than 15 tonnes.
